in accordance with 1.5.1 of ADR on certificates of training for drivers in accordance with 8.2.2.8.2 of ADR and certificates for dangerous goods safety advisers in accordance with 1.8.3.7 of ADR

- By way of derogation from the provisions of the first subparagraph of 8.2.2.8.2 of ADR, all driver training certificates whose period of validity expires between 1. March 2020 and 1. November 2020, stay valid until 30. November 2020. Certificates must be renewed if the driver can prove, that he has attended a refresher training course in accordance with 8.2.2.5 of ADR before 1. December 2020 and has passed an examination in accordance with 8.2.2.7 of ADR. The competent authority must issue a new certificate valid for a period of five years, starting from the date of expiry of the previous certificate.
- 2) By way of derogation from the provisions of 1.8.3.16.1 of ADR, all training certificates for dangerous goods safety advisers, whose period of validity expires between 1 March 2020 and 1. November 2020, shall remain valid. The period of validity of these certificates must be extended by five years from the date of their expiry if the holder of the certificate has passed a test in accordance with 1.8.3.16.2 of ADR.
- 3) This agreement is valid until 1. December 2020 for carriage on the territories of the Contracting Parties to the ADR which have signed this agreement. If it is revoked before that date by one of the signatories, it shall, until that date, apply only to carriage performed in the territories of those Contracting Parties to the ADR which have signed this agreement and which have not revoked it.
