Passengers aged 11 and above from countries listed on the websites of the French Ministries of Health and of the Interior respectively, or who have stayed in these countries in the past thirty days before travel are required to provide a valid negative result of a COVID-19 test carried out less than 72 hours prior to boarding. Arrivals from other countries identified as SARS-CoV-2 active spreading zones are strongly advised to have the negative test result.
